## Biographical sketch

Dr. Marja Airaksinen is professor of social pharmacy in the Faculty of Pharmacy at the University of Helsinki, Finland. She has been involved in several patient information development programs nationally and internationally, e.g., in the WHO/EuroPharm Forum and the Drug Information Division at the United States Pharmacopeia (USP).
