Recent, current, and emerging projects

Jaana Hallamaa is Professor of Social Ethics at the University of Helsinki, Faculty of Theology. Her research interests have extended to both theoretical and practical, or applied, ethics, never straying far from issues of justice and equality. During the first decade of the millennium, Hallamaa concentrated on bioethics and research ethics. Her research topics included the role of Christianity, and especially Lutheranism, in European and Scandinavian social ethics; values and faith in ethics and morality; and the realities and possibilities of pluralism, integration, and consensus in social affairs.

Since 2011 Hallamaa has concentrated on a deeper-reaching project, exploring the theories of action and social action as elements of social ethics. At the centre of this effort is the preparation of a book, tentatively titled *Multilateral Reciprocity: The Conceptual Basis for Ethics of Co-Operation*. The sources of this foundational project include Professor Raimo Tuomela's profound but not particularly easy-to-grasp work in the field. The book, once completed and released nationally and internationally, will grab the attention of social ethicists and action theorists alike, following in the footsteps of Hallamaa's earlier monograph *The Prisms of Moral Personhood*.

Hallamaa's academic approach to social ethics has been to develop theories and concepts as a part of her teaching and supervision, in collaboration with students at all levels. In recent or ongoing postgraduate and doctoral work the tools that she has developed lately have been applied to many questions related to justice and equality, for instance, in the works of Taina Kalliokoski on communalities, Marko Ikonen on clinical supervision, and Johanna Väyrynen on victimhood as actor position.

Hallamaa's research team includes her current and former students who by and large work within the framework that she has created and still develops.
